DIRECTIVE NO. 1

May 29, 2020



When tis time to "Part upon the square"

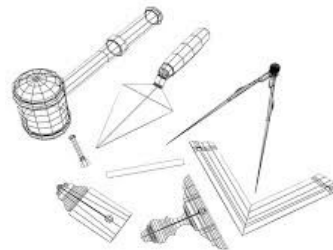

Please continue to follow safety protocols and be safe while the community is opening up again.

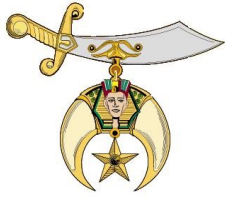
