
**DIRECTIVE NO. 9**

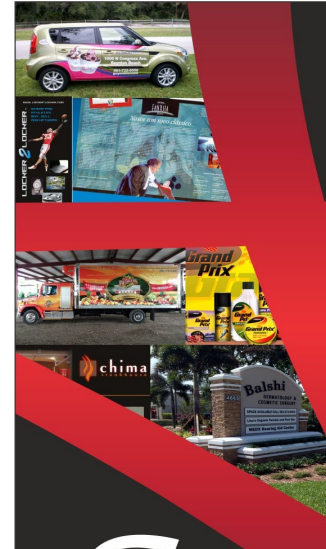
