#### Dear Brothers,

It has been several months since we were initially directed to suspend our Masonic functions, due to the pandemic. On July 13th there were 15,300 COVID-19 cases reported in one day, here in Florida. Fortunately, during the past 2-3 weeks, the number of cases has gone down 1/3 of what was reported in July. Based on these reports, it appears that we are slowly moving in the right direction. Regardless of any current progress, we are still faced with uncertainty, as to when we can return to lodge safely and consistently.

With all the negativity and chaos going on in this country, along with not being fraternally active, it is easy to be pulled away from the "straight and narrow" and become idle. So, during this time of idleness, I decided to challenge myself. Previously, what would typically be a stated meeting night or a called communication, is now replaced with 1 hour of either reading through a degree in my red book, one of the lectures, or reading a charge or two from the blue monitor. As result, I am watching less television, experiencing less stress, and learning more on what it means to be an educated Mason. I would like to challenge each Brother to give this a try. Perhaps starting off with 15-20 min and then gradually increasing the amount over time. You will be surprised how much you will learn, with so little effort.

In our Masonic lessons, we are taught about the nobility and dignity of labor, and the ignobility of idleness:

"Each person has a responsibility to be productive, not just in his own life, but in the lives of others. Work is not a curse from God; it is one of the greatest blessings He has bestowed on us. When we work, when we are productive, when we create something which was not in the world before, when we find answers to problems, we are partaking in the creative nature of God". M&D, 22°

Finally, my Brothers, let us keep close to our hearts, any Brother among us, who is currently ill, and pray for a full recovery from their affliction.


